CIRCULAR TO STUDENTS OF CLASS XI PREFECT AND JUNIOR COUNCIL ELECTIONS

Dear Student,

Greetings from Indian School Muscat!

The school is planning to conduct elections for the Prefects for Class XI on **Thursday, 2nd May 2024**. The detailed instructions and guidelines are given below.

Eligibility for Nomination of Student Prefect:

1. The student should have completed 2 consecutive academic years in Indian School Muscat. The student must have completed a minimum of two years in ISM as of May 2, 2024.
2. The student should have a clear discipline record in the previous and current classes.
3. The student should have secured a minimum of 33% in each subject and 60% in aggregate in the previous class (subject-wise best marks of Half yearly Examination, First Pre Board, and Second Pre Board Examination).
4. The student should be willing to do duties assigned to them by the school authorities

Documents Required for verification:

1. Copy of consolidated Report Card having Half Yearly, First and Second Pre Board marks.
2. Attach the latest passport-size photograph in the school uniform (in .jpg format and size up to 1MB)

Incomplete Nomination forms will be rejected.

Election Procedure:

- The election for prefects will take place physically in the class.
- There will be cross-voting. A student in class XI can vote for any candidate of class XI.

Selection of Junior Council:

1. The first 12 boys and 12 girls who have received the maximum votes will be considered eligible for the next level of selection process of the Junior Council.
2. Copy of Certificates / a written note duly signed with the name of the event coordinator (in case a certificate is not issued). Please note that you need to submit the certificates of participation for the last two academic years only (2022-23 and 2023-24). (Applicable only for the students eligible for the next level of selection process of Junior Council.)
3. In case of a tie, both students will be considered eligible to contest for the Junior Council.

4. The overall criteria for Junior council selection will be based on the average score on: Academics - 30%, Co-curricular and Extracurricular activities -30%, Students vote - 20%, Group Discussion - 20%
5. Based on the eligibility, students will be selected for various positions in the junior council.
6. Students not elected as Junior Council will become prefects of their respective classes.
